Dear Chairman Cochran and Ranking Member Durbin,

Thank you in advance for your receipt of this joint letter of support for the new \$26 million allocation in the Department of Defense's Congressionally-Directed Medical Research Program (PRMRP) for medical research into the underlying causes of aging-related disease (see attached). Our groups urge you to please continue your support of the PRMRP through these new funds.

While we are grateful for the commitment and vision of the National Institutes of Health and National Institute of Aging, one challenge is that most federal and private funding focuses on one disease at a time, whereas a growing body of research reveals connections between the processes of aging and major diseases such as cancer, diabetes, heart disease, among others.

The National Committee for Quality Assurance estimates that 75 percent of the \$1.9 trillion spent on all health care in the United States stems from preventable chronic health conditions - but only 1 percent is allocated to protecting health and preventing illness. Millions of Americans like us are counting on Medicare and private healthcare systems to be able to shoulder the weight of a new generation of aging Americans that already outnumber the young. Right now, with a \$9 billion healthcare increase projected by the CDC over the next 15 years alone, the situation is looking grim.

The U.S. Department of Defense and U.S. Congress are considering a new research program that would fund research that aims to prevent and treat multiple diseases - specifically, the top killers in our state and nation: cancer, Alzheimer's disease, heart disease, and diabetes. These new programs would open up \$26 million in federal funding for research that just makes sense - if we can target the root causes of multiple diseases, then we can find cures and preventions for Americans of any age, and cut broader health and Medicare costs.

One possible project includes the new TAME/Metformin study, recently called "the 5th most innovative project of 2015" by the Washington Post and the subject of the hit Ron Howard documentary "The Age

of Aging". TAME--Taming Aging for Metformin--will test the drug Metformin for use as the first pill to prevent the onset of cancers, diabetes, Alzheimer's, and other aging-related diseases. This project and others will lead to new preventions and medications that Americans of any age can receive, to ensure that the diseases that haunt our nation now might never be a burden for future generations.

By continuing to support the DOD's Peer Reviewed Medical Research Program and these new funding allocations for research into the underlying causes of aging-related diseases, we can ensure a brighter future for all Americans. Please continue your support of this program through the Appropriations process.
